The Korea-Australia Arts Foundation Prize (KAAF) is run annually in cooperation with the Korean Cultural Centre (KCC) which is run by the Korean government. Selected artworks will be exhibited at the KCC in Sydney.

The KAAF for 2023 is open themed and medium to 2D art works. This art prize has both acquisitive and non-acquisitive cash prizes totalling \$24,000.

KAAF's main goal is to seek support for the Australian multicultural society and to take part in promoting and enhancing a truly cultural and ecological community by bringing artists together from diverse ethnicities, from all over the nation.

- Winner - \$20,000 Acquisitive
- 2 Highly Commended - \$2,000 Non-acquisitive

## Terms & Conditions of Entry

The 2023 KAAF Art Prize is open to any artwork in 2D (or 3D wall art) and is open themed and medium.  
Candidates must be 18 years or older and must be an Australian citizen or a permanent resident.  
Entries can be submitted online via link on homepage [kaaf.org.au](http://kaaf.org.au) or using this form and posting/emailing.

### Entry Fee

There is a **non-refundable** fee of \$40 for single entry and \$70 for 2 entries. Entries without payment will not be considered. Payments made by cheque must be made payable to: The Korea-Australia Arts Foundation or KAAF.

Artists must state their name in the reference field and keep proof of payment.  
Receipts will be emailed upon request. KAAF is GST exempt.

A \$1 fee applies for all types of credit card/PayPal transactions.

### Entry Requirements

Apart from online entries, email or postal entries must be accompanied by a completed entry form, cheque or payment receipt (for bank transfers) images, and a short CV - maximum 1 A4 page. Artworks must be of participant's original and completion date must be **later** than January, 2022.  
It must not have been selected for an exhibition/prize elsewhere previously.  
A maximum of **two** entries, each entry limited to **one** digital image can be entered. Single image must not exceed 5MB in size and must be in JPG format. All images must be labelled adhering to following format: Title - Artist First name Surname.  
Actual artworks must not exceed 150cm in width/height including frame and multiple parts such as diptychs/triptychs are accepted but must be within size limits.  
All works selected must be sent with hanging fixtures attached and be marked clearly on the back with the artist's name and title of work. If required, special hanging fixtures must be supplied at time of delivery with clear instructions eg D-rings.  
Selected artists must provide their artworks to the Korean Cultural Centre (KCC) for the entire exhibition period otherwise their place as a finalist will be forfeited and opportunity be given to the next runner up.

Artists or their representatives may not remove any artwork from display prior to 25th January 2024.  
Finalists will allow their works to be reproduced in print and in electronic formats for the purpose of advertising and promoting the art prize.  
The KAAF and KCC will not be held responsible for any loss or damage sustained to artworks whilst in its possession and artworks will not be insured hence it is upto the individual to seek cover.  
The KCC being run by the Korean government, cannot engage in promoting sale of artworks however will not prevent any sales from occurring during the exhibition.  
All personal information gathered by the KAAF will be used solely for the purpose of administering the KAAF Art Prize.  
Finalists will be announced on KAAF website [kaaf.org.au](http://kaaf.org.au) on evening of Sunday, 12th Nov 23.

Artists or their representatives must present ID upon collection of their works. Uncollected artworks WILL NOT be held and KAAF nor KCC will be held responsible for returning uncollected artworks.  
All selected artists will be responsible for the transport of their own work(s) and its cost to and from the KCC.

### Sale of Artworks!

Selected artists are invited to price their works for sale and KAAF is entitled to **30%** commission from any given sale price. **KAAF will take sole agency from when work is selected, during the exhibition period up until bump-out.**  
**Commission WILL NOT be shared with any other agencies.**  
**Unless entered in as NFS at time of entry, artworks will need to be available for sale during the entire exhibition and once submitted, will not be able to change it to NFS; meaning, artists will NOT have it for sale/sell it at a different venue/agency at the same time.**
